Annexure "A"

1. General Information

Purpose of the NIQ – To establish a Web Based Medical e-Books and Journal (National/ International) gateway and discovery service for online medical e-Books and Journal (National/ International) subscribed by MGM Medical College and open access medical journal and e-Books for Medical college at Jamshedpur

2. Scope of Work :

Online International / National Medical e-Books and Journal Gateway for MGM Medical College, Jamshedpur

1. The gateway should aggregate the metadata of more than 15000 online medical journals and more than 15000 e-Books on a single platform.
 2. The platform should have a publisher independent search interface for searching journal articles and other data sets like conference proceedings, book series and audio video lectures
 3. The gateway should enable full text access to more than 7500 open access medical journals along with subscription-based journals.
 4. The gateway should have the facility to configure the library subscribed journals of the college and facilitate the searching of subscribed articles.
 5. The gateway should have personalization service of registering the profile of the user and delivering the alerts to the users about new articles.
 6. The user should be able to set up RSS Feed email alert for every journal indexed in the gateway.
 7. The journals indexed in the gateway should have minimum back files from 2000 onwards unless the journals started publishing later than year 2000.
 8. The gateway should facilitate discovery of journals based on Scimago Ranking, NAAS rating and H-Index.
 9. The gateway should facilitate browsing of Hybrid Open Access Journals
 10. The gateway should facilitate browsing of Table of Content for all journals.
 11. The gateway should facilitate searching within search results.
 12. The gateway should automatically take care of Singular-Plural and US-European English while doing search in the platform.
 13. The articles should display the author email address wherever available in the journal articles.
 14. The search results after performing basic or advanced search should have filtering functionality to filter the results based on subject, country of publications, years, journal name and authors.
 15. Online medical journals published from India should be indexed and searchable in the gateway service.
 16. The gateway should facilitate searching of audio/video talks from publishers who provide subscription to these databases and discoverable through the gateway for a universal discovery.
 17. Time Line – 10 Days from the award of work order.

3. Qualification Criteria

- a. The bidder should be a Business Entity or Consortium shall mean a company registered in India under the Companies Act 1956, or a partnership or proprietor firm registered under the relevant and prevailing law relating to partnership in India, and operating for the last 3 years in Business as of March 31, 2017(**Copy of Proof:** Certificates of incorporation /Company registration Certificates / MOA and AOA or Board Resolution copy)
- b. The bidder should have an average annual turnover of at least INR 50,000.00/-(Fifty Thousand Only) during last three Financial Years 2015-16, 2016-17 and 2017-18. (**Copy of Proof:** Submit audited balance sheet with duly signed and stamped or Certificate from chartered accountant with duly signed and stamped)
- c. The bidder should have been registered with GST. Firm has also to submit the copy of latest GST Return. (**Copy of Proof:** Copy of GST registration/return / Copy of PAN Card)
- d. The gateway should have been developed by an Indian company and should have support office in India.
- e. The gateway should be a part of one of the medical consortium in India
- f. The gateway provider should facilitate access through their data centre/cloud in India

4. General Terms & Condition

- a. The bidder shall submit all the deliverables on due date as per the delivery schedule.
- b. **Performance Bank Guarantee (PBG)**

The successful bidder shall require to make a Security Deposit towards Performance Guarantee in the form of a Bank Guarantee i.e. 10% of the total work order value. The Performance Bank Guarantee shall be drawn from a national scheduled bank in the favour of CEO, JAPIT payable at Ranchi. The deposit shall be refunded upon successful execution of the work orders to the full satisfaction of MGM MEDICAL COLLEGE. The PBG should be valid for total Contract Period + 180 Days from the date of the contract signed.

c. Delay in Implantation

In case of the delay in implementation of project, which is attributable to bidders, exceeds 10 days beyond the prescribed period for implementation, a penalty of 1% of total project cost @ per week will be imposed.
